The College's SC/ST Cell is established to foster the welfare and advancement of SC/ST communities in accordance with the applicable laws and regulations.


The Forum organized four meetings for the academic year 2023-24, the summary of discussions is:






The meeting was scheduled on 20/04/2024 at 12.00pm in Conference Room.

The meeting was held on 11/05/2024 at 12.00pm in Conference room.






The convener welcomed the members for the meeting and discussed pervious minutes of meeting which was held on 9/10/2023.

The convener welcomed the members for the meeting and discussed pervious minutes of meeting which was held on 11/05/2024






In the meeting principal addressed the gathering and informed the working mechanism of the scholarship.
